#### DESCRIPTION

**StarSeal Fixative** is the only product in the market today that helps remove unwanted excess or residual unreacted silicate from polished concrete, one of the main causes of polished concrete food staining. StarSeal Fixative is the crucial middle step in providing true stain resistance for polished concrete. Use when installing a **StarSeal PS Clear FSR** floor.

Using this product will increase the chemical resistance of polished concrete. See TN 30 Chemical Resistance Chart. StarSeal Fixative is designed for use on polished concrete surfaces previously densified with **StarSeal PS Clear**.

#### BENEFITS

- Scavenges and removes hard to rinse excess silicate
- Increases polished concrete's resistance against organic acids and food stains
- Zero VOC

#### SURFACE PREPARATION

After the concrete has been densified to rejection with StarSeal PS Clear and high speed burnished, it is ready for the StarSeal Fixative rinsing process.

#### APPLICATION

- StarSeal Fixative should not be diluted or altered
- Apply with low pressure (20-50 PSI) pump-up sprayer at 500 sq. ft/gallon.
- Follow immediately/close behind with a walk behind scrubber or mop and wet/dry vacuum using plenty of water to rinse the surface completely.
- Do not allow StarSeal Fixative to dry prior to rinsing
- Always rinse the surface more than once.
- Once the concrete is completely rinsed, polishing can begin immediately, if desired.

#### SPECIAL NOTES

- The product should be stored in sealed containers and kept away from extreme heat.
- Shelf Life: If properly stored in its original sealed container, one year from date of manufacture. Rotate your stock.
- For use by certified StarSeal installers only.
