LIMITED MATERIAL WARRANTY

SECTION:

1. For a period of five (5) years commencing on the date on which the concrete surface described herein is coated properly in accordance with manufacturers directions with MOISTUREBLOC [One Step] [Universal] [VRS Emulsion] [VRS FT] and ASTM F 1869 test confirms that the moisture vapor has been reduced by approximately 75% to a minimum of 3.0#/24 hrs/1000 sq. ft.
2. Vexcon Chemicals warrants to the owner that the products will remain adhered to the surface without cracking or peeling and will provide resistance to molds, fungi, and that water vapor levels do not exceed 3.0#/24 hrs./1000 sq. ft. +/- 1#. The warranty covers blistering, peeling or cracking due to water, water vapor or alkali content of concrete. Material must be applied in accordance to manufacturer's instructions or special application instruction per job at the proper film thickness and over suitable clean surface.
3. Additionally, Vexcon also warrants that the adhesive, when properly applied, will adhere to the MOISTUREBLOC when done in accordance with product directions. Vexcon does not warrant the loss of adhesion of the tile adhesive unless caused by water vapor.
4. In the event the coating fails to so perform and as the exclusive remedy for any breach of this warranty, Vexcon Chemicals will at its own expense, supply sufficient MOISTUREBLOC Vapor System and reasonable labor, and floor covering to repair any such failure. This warranty requires a conference with a Vexcon distributor and a Project Conference and Job Survey form, #TN144, must be completed.
5. It is the responsibility of the contractor to follow all product directions and requirements as outlined in the specific Vexcon product data sheet. A completed Job Survey form, TN 144 must accompany this warranty request. Review the Job Survey Form prior to using the Vexcon product.
6. This warranty extends only to conditions arising due to the fault of the material and does not extend to conditions caused by natural disasters, structural defects, building settling or movement, improper floor usage i.e. dragging of heavy equipment, dragging of heavy or sharp items, vandalism or negligence.
7. Any claim under this warranty must be presented during the warranty period and within 14 days after any covered condition has occurred. Notice shall be in writing to Vexcon Chemicals, 7240 State Road, Philadelphia, PA 19135.
8. The warranty period shall not be extended by the replacement of materials under this warranty but the remaining warranty period shall continue in effect and be applicable to the re-coated areas under conditions of the warranty.
9. Vexcon Chemicals makes no other limited warranties whatsoever with respect to any materials sold thereunder, except that such materials shall conform to Seller's physical specifications therefore in effect at the time of shipment and Buyer acknowledges that it is relying upon no other warranty.

THIS LIMITED WARRANTY IS IN LIEU OF ALL OTHER WARRANTIES, EXPRESS OR IMPLIED, INCLUDING, BUT NOT LIMITED TO, THOSE CONCERNING MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE. THIS LIMITED WARRANTY IS ALSO IN LIEU OF ANY OTHER POSSIBLE LIABILITIES OF VEXCON, WHETHER ALLEGED TO ARISE BY AGREEMENT OR BY OPERATION OF LAW.
