A twenty (20) year performance and five (5) year color warranty commencing on the date the concrete surface described herein is treated with the StarSeal PS Color (Finish Coat) FSR system, Vexcon Chemicals warrants to the owner that after the specified burnishing, the treated surface for twenty (20) years will remain water repellant, dust proof, hardened and abrasion resistant and food stain resistant and for five (5) years alkali and UV resistant with no color change greater than Delta E (DE) of three (3). In the event the surface fails to so perform, Vexcon Chemicals will at its own expense, supply sufficient StarSeal PS Color (Finish Coat) FSR products to repair any such failure. A manufacturer's representative must be on site to supervise installation.

A completed Project Conference & Job Survey Form, document TN240, must accompany this warranty request. Review the Job Survey form prior to using this Vexcon product.

It is the responsibility of the contractor to follow all directions and requirements as outlined in Vexcon Product Data Sheets CT105, CT101, CT122 and CT120 and TN101A. A completed Job Survey form TN240 must accompany this warranty request. Review the Job Survey form prior to using the Vexcon product.

Any claim under this limited warranty must be presented during the limited warranty period and within 14 days after any covered condition has occurred. Notice shall be in writing to Vexcon Chemicals, 7240 State Rd., Philadelphia Pa. 19135
