For a period of twenty (20) years commencing the date on which the concrete surface described herein is treated with Certi-Shine Clear, Vexcon Chemicals warrants to the owner that after the specified complete installation, the treated surface will remain water repellent, dust proof, hardened and abrasion resistant. In the event the surface fails to so perform, Vexcon Chemicals will at its own expense, supply sufficient product(s) to repair any such failure. A manufacturer's representative and a certified Certi-Shine installer must be on site to supervise installation.

A completed Certi-Shine Project Conference & Job Survey form TN242, must accompany this warranty request. Review the Job Survey form prior to using Certi-Shine. Note: A warranty for Certi-Shine can only be issued for projects installed by a Certi-Shine certified installer. Contact Vexcon for a list of certified installers.

It is the responsibility of the contractor to follow all directions and requirements as outlined in Certi-Shine installation specification. A completed Job Survey form must accompany this warranty request. Review the Job Survey form prior to using Certi-Shine.

Any claim under this limited warranty must be presented during the limited warranty period and within 14 days after any covered condition has occurred. Notice shall be in writing to Vexcon Chemicals, 7240 State Rd., Philadelphia Pa. 19135

Vexcon Chemicals makes no other limited warranties what so ever with respect to any materials sold thereunder, except that such materials shall conform to Seller's physical specifications therefor in effect at the time of shipment and Buyer acknowledges that it is relying upon no other warranty.
